

#### BACKGROUND

In his January state of the state address, Governor Arnold Schwarzenegger declared 2005 as the Year of Reform. Since making this bold proclamation, Governor Schwarzenegger has outlined an ambitious agenda called the Pillars of Reform, a solutions-based program that encompasses a revamp of the state's budget system, as well as teacher tenure and retirement.

#### WHO WE ARE

Governor Schwarzenegger's California Recovery Team (CRT) is a ballot initiative, grassroots and legislative advocacy organization that provides the political and public support for the Governor's reform agenda. Under California law, the CRT can accept unlimited contributions from either corporations or individuals.

#### THE 2005 AGENDA

Once again, the CRT will play an important role in helping Governor Schwarzenegger accomplish his reform plans through either legislative means or should the legislature refuse to act, at the ballot box with a special election. The CRT will also assist the Governor in opposing measures that are harmful to the state's economy.

#### OUR RECORD OF SUCCESS

During the 2004 election cycle the CRT played an important role in helping the Governor pass Propositions 57 & 58 on the March ballot and in defeating Propositions 65, 68 & 70 on the November ballot. In addition, the CRT was the major funding organization for the teacher's compensation reform committee that gained 1.2 million signatures in 45 days and helped the Governor gain historic legislative reform of the state's public employee compensation system.

**Rules and guidelines for contributions:**  
Governor Schwarzenegger has formed a general purpose ballot measure committee (Governor Schwarzenegger's California Recovery Team, FPPC # 1261406) to raise funds to support the Governor's agenda, through the initiative process, legislative process or through grassroots activities. The committee may also use funds to oppose initiatives that harm the Governor's plan for economic recovery and government reform. Contributions are not tax deductible for federal income tax purposes. There are no limits to contributions to the CRT. Corporate and general PAC contributions are permitted. Contributions from public employee union PAC's will not be accepted. Foreign nationals are prohibited from making contributions to this committee, unless they have permanent residency status in the United States of America (a Green Card).
